PURCHASER AGREES TO PROVIDE THE FOLLOWING AT NO EXPENSE TO ARTIST:

1. High quality professional Sound System, large enough to accommodate at least 105dB sustained throughout the room without distortion.
2. High quality Lighting System including minimum of TWO (2) Follow Spots.
3. SEE EQUIPMENT RIDER ATTACHED. (MUST INCLUDE FOUR WIRELESS MICROPHONES)
4. SEE STAGE PLOT ATTACHED. FOR TECHNICAL QUESTIONS PLEASE CONTACT OUR CONDUCTOR, WILLIAM WEIST AT 732-910-2850
5. Rehearsal time must be DOUBLE the requested performance time.
6. ADVERTISING: In all printed advertisement, such as posters, flyers, and newspaper ads, LITTLE ANTHONY and THE IMPERIALS must receive 100% sole billing, 50% LITTLE ANTHONY and 50% the IMPERIALS. At all times LITTLE ANTHONY and THE IMPERIALS print size must be equal.

A. Correct: LITTLE ANTHONY and THE IMPERIALS

B. Wrong: LITTLE ANTHONY and the Imperials

C. Wrong: Little Anthony and the Imperials

7. On all billboards and marquee advertising LITTLE ANTHONY and the IMPERIALS, the words LITTLE ANTHONY and THE IMPERIALS must be equal size in print.
8. A 50% deposit is required on all dates; payable to IMPERIALS PLUS INC. Balance of money must be paid prior to performance, night of show. Payment must be a certified check, cashiers check, or money order made payable to IMPERIALS PLUS or cash.
9. Internal transportation must be provided to and from airports and to and from venues. LITTLE ANTHONY and THE IMPERIALS must receive limousines or 15 passenger van.
10. An additional van must always be provided for band gear and luggage traveling with LITTLE ANTHONY and THE IMPERIALS.
11.
Limousine or van must be large enough to transport a minimum of EIGHT (8) people and a van for luggage if necessary.
12.
Eight (8) prepaid rooms, to include TWO SUITES NO EXCEPTIONS for (Anthony Gourdine and Clarence Collins) at a Four to Five Star Hotel (HILTON, SHERATON, OR BETTER) close to the engagement must be provided. Extra rooms must be provided for the band if Artist is required to supply additional back up musicians. All rooms must be king – non-smoking. Artists to receive rooms one day prior to engagement (SEE ITEM # 13)

HOTEL CONFIRMATIONS NUMBER MUST BE SENT TO BRENDA COLLINS IN ADVANCE

ROOM LIST (unless other wise changes made by Brenda Collins in advance)

1. ANTHONY GOURDINE – LITTLE ANTHONY- SUITE (no exception)
2. CLARENCE COLLINS –OWNER/IMPERIAL- SUITE (no exception)
3. ERNEST WRIGHT -IMPERIAL- KING SINGLE
4. ROBERT LeBLANC-IMPERIAL- KING SINGLE
5. JOHN DIGIULIO -DRUMMER- KING SINGLE
6. WILLIAM WEIST –CONDUCTOR/1ST KEY- KING SINGLE
7. DALE HERR -GUITAR- KING SINGLE
8. ERIC MAURIELLO -BASS- KING SINGLE

The above group is the main core group for LAI and travels together on all gigs.

If promoter supplies additional Musicians, they should supply: Four (4) horns (2 trumpets, 2 Reeds (1 Alto/Bari/Flute:1 Tenor/Flute) and 2nd keyboard player.

14.

In some cases, LITTLE ANTHONY and THE IMPERIALS will supply their horn section and 2nd keys. If LITTLE ANTHONY AND THE IMPERIALS provide their own band (5 additional players) hotel rooms must be provided if needed.

15.

All musicians supplied by PROMOTER MUST be able to read music (notes and cords) and follow conductor's direction. Violation of this is cause for Artist to retain all fees without necessity of performance.

16.

Back-up musicians supplied by PURCHASER must be dressed in black dress pants with matching shirts.

17.

ALL MUSICIANS, supplied by LITTLE ANTHONY and the IMPERIALS must receive a hot meal following rehearsal or after show completion. If meal vouchers are provided, All LAI core members are to be treated as equals.

18.

Hot meals consist of salad; chicken, fish, or turkey, two vegetables, and potatoes. NO RED MEAT.

19.

Two large comfortable dressing rooms with locks and keys suitable for EIGHT (8) people. Each room must be equipped with lights, mirrors, clothing rack, running water, and towels. Room 1 is for Little Anthony and The Imperials (4 people). The second room is for core band (4 people). If LITTLE ANTHONY and THE IMPERIALS are supplying their own band, than an additional dressing rooms must be provided (5 people).

20.

Hospitality to be provided by PURCHASER in dressing rooms to consist of HOT WATER, TEA, HONEY, LEMON, SPRING WATER, ASSORTED FRUIT JUICES, DIET COKE OR PEPSI, VEGETABLE PLATTER, AND FRUIT PLATTER.

21.

On stage, ONE CASE BOTTLED WATER (Poland Spring, Dasani, ETC.) At room temperature and TWELVE (12) black towels provided for sole use by LITTLE ANTHONY and the IMPERIALS.

22.

Under no circumstance will the following be allowed without written

consent of Imperials Plus, Inc.; TV cameras, video cameras, 8-mm cameras, or any audio recording devices. LITTLE ANTHONY and THE IMPERIALS RESERVE THE RIGHT TO STOP THE SHOW UNTIL SUCH DEVICES ARE REMOVED.

23.

ARTIST must be informed no less than five (5) days prior, of any interviews, television appearance, radio interviews, or spots. Any request for the ARTIST to appear at receptions before or after the engagement must be cleared by IMPERIALS PLUS at least five (5) days prior to the engagement.

24.

PURCHASER must provide twenty five (25) tickets per performance at no cost to ARTIST. This can not be changed without prior consent by Clarence Collins or Brenda Collins.

25.

MERCHANDISE: LITTLE ANTHONY AND THE IMPERIALS will sell and sign CD's and pictures after each performance. If Artist sells there will be no more than 10% given to venue. If venue provides sellers – percentage will be no more than 15 – 20%.

26.

If contract is signed out of the normal span of time between signing and actual engagement, a forty five (45) day cancellation clause is automatically in effect.

27.

For example: Major television appearance, movies, recording, tours that may be beneficial to ARTIST career, ARTIST HAS THE OPTION TO CANCEL.
